#### Please retain the following information for your reference

- Applications for booth space Must be received by February 26th, 2015. Applications will be processed on a first come, first served basis. Please note that booth spaces sell out early!
- 2. Full payment or authorization to bill to corporate office is due with application.
- 3. Exhibitors *may not sublease or share* their booth space.
- 4. The exhibitor must conduct all activities within their assigned booth space. Raffle tickets, ect. May not be sold outside of the exhibitor's booth. A representative for the exhibitor should be on duty at all times during the hours of the show.
- 5. Exhibitors are prohibited from affixing items to the walls or floors. Please use care when moving item, so as not to damage the floor.
- 6. Set up time for Friday March 6th will be at 5pm.
- 7. **Exhibitors may not break down their booth before 3pm!** Any exhibitors who do will not be invited back the following year.
- 8. The Chamber reserves the right to limit the number of vendors in a particular category or franchise.
- 9. The Chamber will not be responsible for the safety of the exhibitor's property from theft, damage fire,accident, conditions of the exhibit building, acts of third parties or other causes. The Chamber will, however, use reasonable care to protect the exhibitor against damage. It is agreed that the exhibitor will defend, indemnify and hold harmless the Chamber, it's agents and employees and the owners of the exhibit for any claims made against them for damages, including bodily injury or death, which may arise out of the exhibitor's use of the premises.
- 10. Arrangements not covered specifically by the preceding Rules and Regulations should be agreed to in writing with the Chamber.

#### Rules regarding sales, gifts and favors:

- 1. The Exhibitor will be allowed to distribute giveaways, sell items, take orders, plan follow up calls, perform demonstrations and secure names and addresses for mailing purposes.
