## Boating on the Dismal Swamp Canal



The Dismal Swamp Welcome Center is

wrapping up another year of service to our waterway as well as highway travelers. We have had approximately 1,500 boats travel through the historic Dismal Swamp Canal this year, down slightly, but the Canal was closed during January and February due to the



replacement of the "River Gate" at the South Mills lock. Hurricane Sandy and two nor'easters forced many boaters to delay moving south due to bad weather.

Boater's genuinely appreciate the hospitality and beautiful well-kept grounds of the NCDOT facility and are also being reminded of the Lamb's Marina's upgrades last winter to accommodate deeper drafts for use of their facilities here in



Camden. They often borrow our loaner bikes to pay a visit to the South Mills village for supplies while staying in the area.

We are in constant contact with many of the online boating newsletters, keeping them abreast of the latest information regarding this historic waterway, which many boaters tell us is

one of the highlights on their travels.

#### **Dismal Swamp Trail Marker Dedication**



On Nov. 1, 2012, an interpretive sign was unveiled to share the history of the mysterious granite Mile Markers which are found along the banks of the historic Dismal Swamp Canal. Located approximately one mile from the south end of the paved portion of the trail, this reclaimed marker, #19, is prominently displayed on the high bank of the Canal. This sign provides a brief history of these stones and was dedicated to the former Director of the Dismal Swamp Welcome Center, Ms. Penny Leary-Smith.

#### **Dismal Day A Huge Success**



This first annual event, was organized to draw attention to the swamp's history. It attracted approximately 1000 people and was a big hit with tourists and area locals. Food vendors sold out and additional boat rides were added due to popularity. The events included a 5K Family Fun Run, bounce houses, live music, arts and crafts vendors and an up-close view of an old moonshine still and lighter boat.

In addition to the routine services offered by the Camden County Offices, Camden County also offers these valuable programs & services:





#### **Community Vision**

Camden County stands at a pivotal point in the county's history. Opportunities lie ahead and the county is preparing to become a successful rural community of the 21<sup>st</sup> century -- a county with new energy and a new vision.



This new vision is encapsulated in the county's community vision statement. It describes the kind of community that residents, business owners, and leaders want Camden County to be in the future. It describes the hopes and aspirations for the community and provides a concise description of what Camden County will strive to be by the year 2035. The vision statement was developed from community input generated at the Envision Camden County Public Workshop.

#### **Vision Statement**

Camden County will realize its goal to be a community with "new energy and a new vision" by embracing and capitalizing on its assets - abundant natural resources, a unique rural setting, and a high quality workforce and educational system. Emphasis will be placed on providing a good quality of life for residents in a manner that is fiscally efficient and that preserves rural community assets.

New development will be focused within targeted core areas to breathe new life into established county villages and to efficiently use existing and planned infrastructure and public resources. New housing choices will be made available to serve families, young professionals, and retirees. Rural areas will maintain prominence in the county, and will continue to serve agricultural and forestry production and low density residential development.

New employment development will broaden the county's tax base and will be developed within strategic locations to maximize use of public infrastructure. Commercial and employment development will provide new goods and services and valuable employment opportunities to established residents. New industries will be low impact and will be designed to protect critical natural resources. The county will offer opportunities for residents and visitors to explore the natural wonder of Camden County by providing new hospitality and recreational amenities

The Bicycle Plan Committee held it's second meeting on December 6, 2012 at the Pasquotank County Public Safety Building, 2<sup>nd</sup> Floor (200 East Colonial Avenue, Elizabeth City, NC).

The following is a summary of that meeting:

#### Presentation

• Matt Hayes and Anne Eshleman of Alta/Greenways presented on existing conditions findings.

#### **General Comments**

- Traffic Safety Report was effective in getting engineering improvements on US-158. Add to Albemarle website for easy access
- CTG Steve and Liz are studying planning /policies that address health and coming up with policy statements for comprehensive plans, CAMA plans, etc. Bike Plan should coordinate with planning/policy recs in this plan.
- Watch for Me NC is expanding out of the Triangle region and covering bike safety soon.
   Food Lion in OBX is interested in helping/partnering on this. Hyde County Intercounty transportation may be able to put signs on their vehicles (contact Liz Mumm)
- Target managers/mayors for education/encouragement/enforcement efforts they are already involved and concerned
- OBX population increases 10x in summer; 250,000-300,000 per week in the summer (mid-June through Mid-August); Follow up needed on previous exchange with Dare County Tourism
- Cost estimates for facilities and maintenance will be useful in the implementation chapter (coming in the full draft plan)
- Alta to send out doodle poll for one of the last two weeks in January
  - o 10 am or later
  - Currituck can host and provide lunch if everyone is willing to pay 5 to 10 dollars

#### **Tax Department**

The 2012 county taxes are due by January 5, 2013, due to the 5th falling on the weekend you have until January 7, 2013 to pay before interest accrues. The listing period for personal property is during the month of January, 2013. It has to be listed by January 31, 2013, after that date there is a late listing penalty. Customers that have previously listed personal property will receive a listing form in the mail to review and sign. If you have never listed before and need to this year, please come by our office or call and we can mail a form to you.

Starting next year there will be a change in the vehicle billing. You will receive your tax bill through DMV along with your registration renewal. This is starting with March renewals due July 1. Tax office will still upload the bill information and process values and situs then we forward to DMV. There is a brochure in the newsletter as well for you to read that explains how the process will work.

## **Camden County Department of Social Services**

#### **Energy Assistance Program**

Applications for the Low Income Energy Assistance Program (LIEAP) will be taken now through January 31, 2013 for specified households. These households should consist of persons 60 years old and over or those who are disabled (could be under 60) and receiving Adult/Aging services. Applications for all other households will begin on February 1, 2013 through March 28, 2013 until funds are exhausted. The LIEAP provides a one-time annual vendor payment to help eligible families pay their heating expense. All applicants have to be within income and resource limits and must be responsible for paying their own heating costs. Payments vary and are based on income, household size and heat source. For more information contact Camden County Department of Social Services at 252-331-4787.

#### Special Assistance In-Home Program (SA/IH)

Camden County Department of Social Services is offering this program now. It is a program designed to provide an alternative to placement in an Adult Care Home for those who can live safely at home with appropriate services. It allows recipients choice of a less restrictive setting and more control over managing their daily lives. All persons must need "adult care home" level of care as verified by a valid FL-2 from a health care provider and meet income and resource requirements. The target population is for persons who are 18 and older desiring to remain at home, who can do so safely based on a social worker's assessment. The Special Assistance In-Home Program started as a demonstration project in September 2000 with 400 slots and 22 participating DSSs. It has continuously grown through the years with voluntary participation by DSSs. Legislation in 2007 established the SA/IH as a permanent program under General Statutes and allowed for program expansion. Legislation in 2012 requires all 100 DSSs to participate. Slots have already been assigned for Camden DSS and we hope to fill them soon. If you or someone you know can benefit from this kind of program, please give us a call at 252-331-4787.
