MINUTES

The regular meeting of the Camden County Board of Commissioners was held on Tuesday, January 16, 2007 at 7:00 p.m. in the Historic Courthouse, Camden, North Carolina. The following members were present:

Chairman Jeffrey B. Jennings
Vice Chairman Philip Faison
Commissioners Melvin J. Jeralds, Carolyn O. Riggs, and Mike Andrews

Also attending was County Manager Randell Woodruff, Clerk to the Board Ava Gurganus, and County Attorney John Morrison.

Chairman Jeffrey Jennings called the meeting to order. Commissioner Mike Andrews gave the invocation and led the Pledge of Allegiance.

Public Comments

Chairman Jeffrey Jennings stated public comments are an opportunity for citizens or property owners to speak and comments will be limited to two (2) to three (3) minutes.

Gary Overton, 1291 South 343, asked to speak regarding his property taxes. Mr. Overton stated that he had meet with the revaluation person who set his property taxes and he was informed that his next appeal was to the Board of Commissioners.

Chairman Jeffrey Jennings stated the Board of Equalization and Review who will hear tax appeals in April. Chairman Jeffrey Jennings informed Mr. Overton that the members of the Board of Commissioners are also the members of the Board of Equalization and Review.

Attorney John Morrison advised that an appeal would be a quasi judicial hearing with sworn testimony and a decision is based on the evidence provided at that hearing. Mr. Morrison further stated it is not in the proper form and not appropriate at this time for the Board of Commissioners to consider Mr. Overton's property taxes since the Board of Commissioners also sit as the Board of Equalization and Review.

Chairman Jeffrey Jennings advised Mr. Overton that the Board would hold Equalization and Review hearings in April and Mr. Overton would be notified by the Tax Administrator by mail of a hearing date.

Pat Cuthrell, 104 Craven River Court, urged the Board to make a decision regarding the landfill themselves and spoke in favor of the Black Bear Sanitary Landfill.

Roger Lambertson, 162 Sand Hills Road, stated that he objected to the comments regarding the landfill due to the fact that the Black Bear Sanitary Landfill was on the agenda and felt Mrs. Cuthrell's comments were out of order.

Kenny Simmons, 538 Trotman Road, stated that the citizens trusted the Board to make a decision that will support the people and spoke in favor of the Black Bear Sanitary Landfill.

Bill Bland, 112 Deer Trail, spoke in opposition to the first Monday of each month Commissioners meeting being held in the morning.

Bill Norton, 339 Lambs Road, spoke in favor of the Commissioners meeting in the morning..

Amy Cowen, Health Promotions Coordinator with Camden County Health Department and Albemarle Regional Health Services, stated that the 2006 Community Health Assessment has been completed, which contains vital statistical information including secondary data based on health, social economic, environmental and demographic information about Camden County as well as community surveys and opinions about things going on in Camden County that may aide the Board in decision making for 2007. The Health Departments puts together this document every four (4) years which is funded by several local agencies. This document is available on CD or hard copy upon request of the Board.

Marvin Myers 109 Deer Trail, spoke in opposition of the Black Bear Sanitary Landfill.

<u>Consideration of Minutes</u> <u>December 4, 2006 – Regular and Organizational Meeting</u> <u>and January 2, 2007 – Regular Meeting</u>

Commissioner Melvin Jeralds made a motion to approve the minutes of the December 4, 2006 – Regular and Organizational Meeting and January 2, 2007 – Regular Meeting subject to correction of technical and typographical errors. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Consideration of Agenda

Commissioner Mike Andrews made a motion to approve the agenda as presented. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

<u>Public Hearing - Ordinance No. 2007-01-01 - An Ordinance of the Camden County</u> <u>Board of Commissioners Regarding Adequate Public Facilities</u>

Commissioner Philip Faison made a motion to go into public hearing to receive comments on Ordinance No. 2007-01-01. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Following the Commissioners' November 13, 2006 work session on growth management tools, Attorney Courtney Hull prepared a draft Adequate Public Facilities Ordinance. The ordinance provides a method and criteria by which residential subdivision proposals can be evaluated to determine their potential impact on school facilities, and applicants are provided alternatives to remedy inadequacies. The objective is to establish concurrency between residential development and facilities needed to provide related public services.

The draft includes several items that are highlighted as optional or discretionary as to specifics. The Commissioners will need to address these items in order to finalize the ordinance.

This matter was set for public hearing at the January 2, 2007 Commissioners meeting and advertised in the Daily Advance.

Planning Director Dan Porter presented a PowerPoint presentation regarding Ordinance No. 2007-01-01.

Commissioner Philip Faison referred to exemptions in the ordinance and cited one example is parent to child.

Planning Director Dan Porter stated that exemption is not included and there are only three (3) exemptions included in the adequate public facilities ordinance.

Commissioner Faison asked if more exemptions can be included.

Planning Director Dan Porter stated that it is the Board's ordinance and it is written to be fair across the board and the test for adequate capacity would be taken at the building permit stage, which is one by one as they come in the office. Dan Porter further stated this gives the ability to not call this ordinance a subdivision relatedordinance therefore getting away from the state statutes that require that certain types of development are exempted from consideration of the subdivision ordinance.

Commissioner Philip Faison asked if the Certificates are issued at time of development or at developmental stage.

Planning Director Dan Porter stated the ordinance is written to be at the building permit stage but it could be written at the subdivision approval stage.

Commissioner Philip Faison inquired regarding why would an automatic approval occur after five (5) years instead of three (3) years from the original application date.

Planning Director Dan Porter stated this is a discretionary item for consideration by the Board and Capital Improvements Plans are generally five-ten-fifteen year plans.

Commissioner Mike Andrews questioned if there will be a waiting list for developers if there is not adequate facilities.

Planning Director Dan Porter stated the developer can phase the project so that the project will not exceed the capacity.

Commissioner Carolyn Riggs asked for clarification of Dan Porter's statement regarding money flowing back to the school.

Planning Director Dan Porter stated the option is included in the ordinance for contribution other than the dollars that is mentioned or the dedicated land for schools and if the Board chooses to accept something else that is important to the county services, the way this ordinance reads it would appear that this could be done. However, the value would have to benefit the schools stated needs.

Commissioner Carolyn Riggs question the feasibility of the five (5) year time frame instead of ten (10) years for the developer to reapply due to adequate capacity.

Commissioner Carolyn Riggs questioned if this ordinance was giving the developer vested interest.

Planning Director Dan Porter stated the developer is typically vested at preliminary plat approval. However, we are assuming vested rights do not occur with regards to the adequate public facilities ordinance.

Commissioner Philip Faison questioned if a permit would be issued if the capacity is down at all schools.

Dan Porter stated the way the ordinance is written is if the applicant fails the capacity tests at one of the schools, then the advancement capacity prevails for the entire system.

Chairman called for any comments from the public.

Following discussion and questions from the Board, Planning Director Dan Porter suggested that this matter be recessed until February 19, 2006 for further study and consideration of Ordinance No. 2007-01-01 by the Board.

Hearing no comments, Chairman recessed the public hearing until Monday, February 19, 2006 at 7:00 p.m. or as soon thereafter as the agenda allows.

Request for Referendum - Sanitary Landfill Extension Agreement

Commissioner Carolyn Riggs made a motion to request that a referendum vote regarding the Black Bear Sanitary Landfill Extension Agreement be approved by the House and Senate. The motion failed with Commissioners Melvin Jeralds, Philip Faison and Chairman Jeffrey Jennings voting no; Commissioners Carolyn Riggs and Mike Andrews voting yes; no Commissioner absent; and no Commissioner not voting.

Consideration of Ordinance No. 2007-01-01 An Ordinance of the Camden County **Board of Commissioners Regarding Adequate Public Facilities**

Chairman Jeffrey Jennings stuck this matter from the agenda due to the fact that the public hearing was recessed until Monday, February 19, 2007 at 7:00 p.m. or as soon thereafter as the agenda allows.

<u>Set Public Hearing - Courthouse - Shiloh Fire Commission - Purchase of Sutphen</u> **Rescue-Pumper Fire Truck**

Commissioner Philip Faison made a motion to set public hearing regarding Courthouse Fire Commission purchase of Sutphen Rescue Pumper Fire Truck on Monday, February 19, 2007 at 7:05 p.m. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Community Planning Process

Planning Director Dan Porter reported that following the site visit by the Smart Growth Leadership Institute, the Planning Board has held several discussions regarding how to position the county for the development proposal surge expected when the moratorium is lifted, as well as the long range development of the county. These discussions are also relevant to the ongoing review and revision of the county's Unified Development Code.

One of the focuses of discussion at the Smart Growth meetings is the need to have a community discussion about the patterns and standards of development. As a very rural sparsely populated county, Camden has not had the need to develop mechanisms for community involvement for this type of decision making, whether through government or other social institutions. Instead, community involvement has been reactive to individual issues of the moment.

The Planning Board is therefore recommending that the County Commissioners support a community planning process to lay the ground work for future decisions regarding the overall development of the County. To that end the Board is beginning to prepare a scope of work for the community discussion by establishing the following goals and objectives of a citizen participation "process", and "outcomes" of the process:

Citizen Participation Process

To conduct an effective community outreach process that is supported by the county Commissioners, is open and encourages positive discussion among all citizens, and utilizes expertise from a variety of sources with knowledge and experience of the County's environmental and development conditions. The result should be support for ongoing discussions, and raising understanding/ability to objectively plan for and evaluate development decisions facing Camden County.

Citizen Participation Outcomes

To increase the community's knowledge of the variety, inter-relationship, and long term consequences of development decisions. The result should be recommendations for: 1) a unified vision of the future; 2) patterns and standards of development; 3) protection of environmental resources; 4) policies related to level of services needed and desired; and 5) an attractive sustainable built environment.

County Manager Randell Woodruff stated this matter could be considered at the scheduled retreat on February 16, 2007.

Hearing no objections, Chairman Jeffrey Jennings tabled this matter until the February 19, 2007 Commissioners meeting to allow further consideration at the Board retreat.

NC Housing Finance Agency (NCHFA)- Single Family Rehabilitation Program 2007 (SFR2007)

Planning Director Dan Porter stated Camden County has been awarded a grant of \$200,000.00 from the North Carolina Housing Finance Agency for the 2007 Single Family Rehabilitation Program. This program is very similar to the CDBG Scattered Site Program that we are currently finishing up, utilizing Holland Consulting Planners as the program administrator.

Holland Consulting Planners assisted in the preparation of this NCHFA application, and anticipates being able to rehabilitate three (3) to four (4) houses with this grant.

Commissioner Philip Faison made a motion to accept the NCHFA SFR2007 grant of \$200,000.00 and authorize the Chairman and necessary staff to execute all appropriate documents. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Commissioner Mike Andrews made a motion to approve Holland Consulting Planners to act as program administrator for the NCHFA SFR2007 grant and prepare a contract for presentation to the Board. The motion passed with Commissioners Melvin Jeralds, Carolyn Riggs, Mike Andrews, Philip Faison and Chairman Jeffrey Jennings voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

<u>Set Public Hearing - Special Use Permit Application - UDO 2006-11-24 - Athletic</u> Field - Camden County

Commissioner Mike Andrews made a motion to set Special Use Permit Application – UDO 2006-11-24 - Athletic Field for public hearing on Monday, February 19, 2007 at 7:00 p.m. or as soon thereafter as the agenda allows. County Manager wanted to know if anyone was interested so arrangements can be made.

There are no major problems at this time with the MediaCom audit.

Training session:

Will be held at IOG on March 21 for manager evaluation and Board self assessment.

Martin Luther King Unity Walk

MLK activities were successful with approximately 175 attending. Commissioners Philip Faison and Mike Andrews spoke.

General Assembly

On Wednesday, January 24 the General Assembly will convene and a trip to Raleigh is planned.

Moving forward with plans for retreat at Blackwater on Friday, February 16.

Education Forum

Will be held on Thursday, January 18 in Edenton.

US 17 Association

The Association advocates on the state level for improvements on US 17. The County Manager will be attending the meeting in New Bern on Monday, January 22, 2007.

Utility Franchise Fees

Still waiting for official notification of how much utility franchise fees the county will receive since becoming a unified government.

South Mills Fire Contract:

Attorney John Morrison is working on a contract in an effort to move forward and will provide an attorney client privileged contract for the Board to review.

Mike Andrews questioned if that was for both fire department's contracts.

County Manager stated this is for the South Mills Fire Department but both contracts need to be consistent.

Hearing no objections, Chairman Jennings so order Attorney John Morrison to research the rationale of a Fire Commission.

Cable Administration

Effective January 1, 2007 a law enacts a number of changes that will impact cable television companies and this is done locally but taken over by state. Local government will handle customer complaints.

Other Matters

Commissioner Carolyn Riggs stated opposition to Congressman Butterfield getting Washington to tell us how to handle Medicaid cost.

Commissioner Carolyn Riggs asked the County Manager for update on CAMTECH regarding recording taping the Commissioners meetings.

The County Manager has spoken with Superintendent Ron Melchiorre and other school staff and stated that the county has the equipment for taping the meetings, cameras would have to be purchased in order for the CAMTECH students to show the meetings the next day.

Commissioner Carolyn Riggs stated there is grant monies for the cameras according to CAMTECH Principal Ina Lane.

Commissioner Mike Andrews asked what the status of the US17 bike path guard rail.

The County Manager stated that according to Anthony Roper this project has been set back into the fall and will be put in place out of discretionary funds.
