The FY2006-2007 budget public hearing of the Camden County Board of Commissioners was held Monday, May 22, 2006 at 7:00 p.m. in the upstairs courtroom, Courthouse Complex, Camden, North Carolina. The following members were present:

Chairman Melvin Jeralds stated that Commissioner Jeffrey Jennings was absent due to a previous engagement.

Also present was County Manager Randell Woodruff, Clerk to the Board Ava Murgia, and Finance Officer Clarann Mansfield.

FY 2006-2007 Budget Public Hearing – Ordinance No. 2006-05-01 An Ordinance of the Board of County Commissioners of Camden County, NC Relating to the FY2006-2007 Budget

At the May 9, May 11, and May 16 Budget Workshops several changes were recommended and are incorporated in Ordinance No. 2006-05-01.

At the May 1, 2006 Commissioners meeting, the public hearing was set for Monday, May 22, 2006 in order to receive comments from the public regarding Ordinance No. 2006-05-01. Public Notice, as required, was given in the Daily Advance on Monday, May 8, 2005 with follow up ads in the *What's Up In The Albemarle* section of the Daily Advance.

Commissioner Carolyn Riggs made a motion to open Public Hearing to receive comments from the public regarding Ordinance No. 2006-05-01. The motion passed with Commissioners Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; Commissioner Jeffrey Jennings absent; no Commissioner not voting.

Chairman Jeralds stated there was no proposed tax increases for 2006-2007 budget and the taxes would stay the same as last year.

Chairman Jeralds called for any comments from the public.

Hearing no comments from the public, Commissioner Clayton Riggs made a motion to close public hearing regarding FY2006-2007 county budget. The motion passed with Commissioners Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; Commissioner Jeffrey Jennings absent; no Commissioner not voting.
