## **MINUTES**

The FY2006-2007 budget work session of the Camden County Board of Commissioners was held Thursday, June 1, 2006 at 6:00 p.m. in the upstairs courtroom, Courthouse Complex, Camden, North Carolina. The following members were present:

Chairman Melvin Jeralds called the FY2006-2007 work session to order and stated the purpose of the work session was to review the revised FY2006-2007 budget.

Discussion was held and the following motions were made regarding the FY2006-2007 budget:

- Commissioner Clayton Riggs made a motion to approve the following employee benefits for FY2006-2007: 5% 401K, 4% COLA, Longevity stays the same as last budget year - FY2005-2006, and no merit pay included in the benefits. The motion passed with Commissioner Jeffrey Jennings, Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.
- Commissioner Mike Andrews made a motion to create a Camden County Recreation Department within the General Fund with a Miscellaneous line item in the amount of \$70,000.00. The motion passed with Commissioner Jeffrey Jennings, Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.
- Commissioner Jeffrey Jennings made a motion to add a line item for teacher's supplement in the amount of \$13,800.00 in the General Fund Special Appropriations. The motion passed with Commissioner Jeffrey Jennings, Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.
- Commissioner Clayton Riggs made a motion to increase the Courthouse Restoration Fund to \$30,000.00. The motion passed with Commissioner Jeffrey Jennings, Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.
- Commissioner Jeffrey Jennings made a motion to amend the Parks Grants Fund line item to \$40,000.00 for the Blue Cross/Blue Shield Fit Together Grant. The motion passed with Commissioner Jeffrey Jennings, Carolyn Riggs, Clayton Riggs, Mike Andrews and Chairman Melvin Jeralds voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.
