The regular meeting of the Camden County Board of Commissioners was held Monday, February 7, 2005 at 7:00 p.m. in the Camden County Courthouse, Courthouse Complex. The following members were present:

Also attending was Attorney Herbert Mullen, Finance Officer Clarann Mansfield, and Planning Director Dan Porter.

Chairman Jeralds called the regular meeting to order. Commissioner Andrews gave the invocation and lead the Pledge of Allegiance.

Public Comments

Chairman Jeralds called for any comments from the public and stated that due to the schedule public meeting on Tuesday, February 8, 2005 at 7:00 p.m., no comments regarding the Black Bear Disposal Landfill would be taken.

Buddy Tucker, 617 Trotman Road, spoke regarding a code violation notice he had received. Mr. Tucker stated his son is in Iraq.

Chairman Jeralds asked Mr. Tucker to speak to Planning Director Dan Porter regarding his issues.

Consideration of Minutes - December 16, 2004 Joint Meeting with the Planning Board, January 3, 2005 Regular Meeting and January 10, 2005 Joint Meeting with the Albemarle Jail Commission

Commissioner Jennings made a motion to approve the minutes of the December 16, 2004 Joint Meeting with the Planning Board, January 3, 2005 Regular Meeting and January 10, 2005 Joint Meeting with the Albemarle Jail Commission, subject to correction of typographical and technical errors. The motion passed with Chairman Jeralds, Commissioners Jennings, Carolyn Riggs, Clayton Riggs, and Andrews voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Scattered Site Housing Program 2005-2008 Reset 2nd Public Hearing and Resolution No. 2005-02-02 Authorizing the Camden County Board of Commissioners to Serve as the Scattered Site Housing Selection Committee for the 2005 CDBG Grant

This matter was set for public hearing at the December 6 Board meeting and advertised in the Daily Advance for two (2) hearings on January 3 and February 7, 2005.

The first Public Hearing was held January 3, 2005, and no comments were received from the public.

The second public hearing is being delayed until February 21, 2005 because the Board is required to adopt Resolution No. 2005-02-02 which authorizes the Camden County Board of Commissioners to serve as the SSH Selection Committee and to work with staff and the consultant to select recipients and implement the program.

Planning Director Dan Porter stated he received a memo from J. Reed Whitesell, AICP Senior Vice President on January 17, 2005 regarding the following:

"Camden County's application for FY05 CDBG Scattered Site funds is due on February 28, 2005. Contrary to earlier procedure, the Division of Community Assistance is requesting that the housing beneficiaries be identified <u>prior</u> to submittal of the application. Since the county just commenced its outreach and application processing procedure, it may be as late as February 21st before the eight potential beneficiaries are identified. Therefore, I respectfully ask that the Camden County Board of Commissioners designate themselves as the Scattered Site Housing (SSH) Selection Committee at their regularly scheduled meeting on February 7, 2005. The board can then approve the beneficiaries to be included in the application at the next commissioners' meeting on February 21, 2005."

"Be advised that the applicant rating and selection process is based on a completely objective system point system that considers factors including income, special population, and housing need. Our staff will review all applications and provide the Planning Director with a list of eight recommended beneficiaries prior to 2/21/05. This list will be reviewed by an informal housing needs committee including the County Clerk, Planning Director, Building Inspector, and a representative of the Health Department prior to preliminary approval and referral to you for final review on 2/21/05. Also be advised that the board will have a final opportunity to approve all final grant awards prior to actual rehabilitation or replacement. Before your final approval of each grant award, my staff and the informal committee discussed above will perform additional review during project implementation to verify final applicant eligibility and need. There is no need for discussion of income or other household information by the board in public forum; these factors will have been satisfactorily reviewed by our staff and the county staff before your final approval."

Commissioner Andrews made a motion to delay 2nd Public Hearing until February 21, 2005 and to adopt Resolution No. 2005-02-02 designating the Board as the SSH Selection Committee. The motion passed with Chairman Jeralds, Commissioners Jennings, Carolyn Riggs, Clayton Riggs, and Andrews voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

<u>Scattered Site Housing Program 2002 – Hobbs UpChurch</u>

Eric Weatherly read the following statement into the minutes regarding the closure of the 2002 – 2005 Scattered Site Housing Program:

The purpose of this public hearing is to announce the accomplishments of the Community Development Block Grant received for the Scattered Site Housing Project for Camden County in 2002. The Community Development Block Grant program is funded through the United States Department of Housing and Urban Development (HUD), and administered through the North Carolina Department of Commerce, Division of Community Assistance.

With this grant the County had the funding to remove four low to moderate income families from dilapidated housing and replace their existing house with a new double-wide modular home. These four applicants were chosen on the criteria of income, the number of shilders and alleged with the county of children and elderly living in the household, whether any of the inhabitants were handicapped, and the condition of disrepair of the house. What started out as a Rehabilitation Program, was amended to a Relocation Program after an assessment of applicants' houses proved that the structures could not be brought to current building codes within the allotted budget (\$29,999).

The Relocation Program funds the costs for demolition of the existing house, the removal and proper disposal of lead and asbestos material, the removal and replacement of old or non-functioning septic systems, the installation of a new driveway, and the installation and construction of a new double-wide modular home. Costs for utility hookup and relocation funds were also covered by the grant.

The County is eligible for this Community Development Block Grant every three years and the total amount of money received for each round of funding is \$400,000.

Are there any questions?

Hearing no questions, Chairman Jeralds proceeded with the meeting.

Albemarle District Jail

Wayne Jones of Albemarle District Jail was present to answer any questions.

Commissioner Carolyn Riggs asked if a decision was made from Gates and Chowan to join the Albemarle District Jail.

Mr. Jones stated not yet.

Commissioner Andrews asked what the county's share would be.

Commissioner Jennings stated Camden had no choice but to participate.

Commissioner Carolyn Riggs made a motion to support the building of a new jail. The motion passed with Chairman Jeralds, Commissioner Jennings, Carolyn Riggs, and Clayton Riggs voting aye; Commissioner Andrews voting no; no Commissioner absent; and no Commissioner not voting.

Matthew Couch, 136 Culpepper Road, questioned how much the new jail would cost the county.

Commissioner Jennings and Chairman Jeralds answered the county's share would be 13% of \$16,119,948.00.

Commissioner Jennings stated there will be a federal contract to house federal prisoners in the jail and the cost the federal government pays will almost offset the payment of the new jail.

Sheriff Perry stated that the bottom line cost for the county is between \$30,000.00-\$40,000.00 extra a year.

Code Enforcement

Kim Harris, Code Enforcement Officer, was present to answer any questions.

Commissioner Andrews asked Ms. Harris if 916 Trotman Road was vehicles.

Appointment to Recreation Advisory Committee

Hearing no objections, Chairman Jeralds appointed Commissioner Andrews as representative for Camden County on the Elizabeth City-Pasquotank and Camden Recreation Advisory Committee from January 1, 2005 to December 31, 2007.

Elizabeth City State University (ECSU) - Request for Letter Recognizing Dr. Mickey L. Burnim, Chancellor

Staff received a letter of request from ECSU requesting a letter from the Board for Dr. Mickey Burnim, Chancellor of ECSU, who will be recognized at a 10th Anniversary Scholarship Gala to celebrate a decade of his service to ESCU.

This letter/certificate of congratulations will be included in the souvenir program for Chancellor Burnim.

Commissioner Jennings made a motion to send a letter/certificate of congratulations for Dr. Mickey Burnim. The motion passed with Chairman Jeralds, Commissioners Jennings, Carolyn Riggs, Clayton Riggs, and Andrews voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Commissioner Clayton Riggs made a motion to approve the Tax Releases, Pick Ups and Refunds and Refunds to be Issued by the Finance Officer as submitted by the Tax Administrator. The motion passed with Chairman Jeralds, Commissioners Jennings, Carolyn Riggs, Clayton Riggs, and Andrews voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Auto Towing Contract

Planning Director Dan Porter reviewed the proposed auto towing contract in order to establish a more effective and efficient enforcement of County Codes related to junk, abandoned, and unregistered vehicles. The contact would be executed with two (2) towing services for a one (1) year period. With the contract in place the county would need only to issue a work/purchase order for each case (after proper notice) and would have an upper limit to financial exposure.

Over the last several months the Code Enforcement officer has been attempting to enforce the code through referring violations to the court system - hoping that fines and court proceedings would force owners of these vehicles to comply with the ordinance. The results have been mixed at best. Since the ordinance gives Code Enforcement the authority to tow the vehicles, the Code Enforcement Officer intends to proceed as follows:

- Identify violation
- Make a courtesy call and provide limited time to comply
- Send certified letter, place placard on vehicle as notice to comply within a specified time period
- If letter is returned, post legal ad notice to comply by specific date
- On specified date execute work order to have car towed.

At this point the towing service becomes responsible for notice, and any procedures to obtain title to vehicle. If vehicle is not picked up by owner after 30 days storage, the towing service will invoice the County for the set amount agreed upon in the contract.

Chairman Jeralds stated there are possibly four (4) towing services in the county and if they met all the criteria, then they should rotate between all four (4) services.

Commissioner Andrews asked if it was legal to go onto someone's property.

Dan Porter stated that the General Statues allows for the towing service to enter someone's property to tow unregistered vehicles.

Commissioner Andrews asked if farms were included.

Dan Porter stated this applies to any property other than bona fied farms.

Commissioner Andrews asked if there were a means of postponing towing the vehicles.

Dan Porter stated there are no exceptions written into the law; they try to work with people.

Commissioner Carolyn Riggs stated that she did not see why the county should be incumbent upon paying for cleaning out the car.

Dan Porter stated the people who dispose of the vehicle will not accept the vehicle full of garbage.

Chairman Jeralds asked how the county recoups the money.

Dan Porter stated thru a tax lien on the property.

Chairman Jeralds questioned if a tax lien could be put on someone's property if they do not own the vehicle.

Dan Porter stated it does not seem that it could be.

Commissioner Andrews asked if there was a storage fee.

Dan Porter stated the county is not charged for storage fee but when the towing operator picks up the vehicle, then the owner will have to pay the towing and storage charge to the towing company.

Matthew Couch, 136 Culpepper Road, asked if there was any way to protect the military personnel from getting towed while away in the service.

Dan Porter stated an amendment can be made to the ordinance for military personnel.

Attorney Herbert Mullen stated that military personnel are protected by the Soldiers and Sailors Relief Act.

Bill Norton, stated it was his understanding that you are allowed two (2) vehicles on your property so how many vehicles do you keep when you go overseas.

Frank Eason, 916 North 343, stated the Code Enforcement Officer is burdened with work, is the county going to have to hire someone else to keep up with the towing paperwork, and is the county going to be responsible for lien vehicles if they are towed.

Hearing no objections, Chairman Jeralds so ordered the Planning Director to review the ordinance regarding exemption for military and government employees.

John Thompson, 132 County Meadows Road, asked if this discussion was to tow Mr. Tucker's vehicles.

Chairman Jeralds stated no, it was for a towing contract.

Commissioner Jennings made a motion to approve a blanket contract with towing services to be implemented on a case by case basis through issuance of work/purchase orders. The motion passed with Chairman Jeralds, Commissioners Jennings, Carolyn Riggs, Clayton Riggs, and Andrews voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Independent Contractor Status. It is understood that the Contractor is an independent contractor and is not an employee, agent, partner or representative of the Client, and shall not hold himself out to the public as an employee, agent, partner or representative of the Client as an independent contractor, the Contractor is responsible to secure, at his sole cost, worker's compensation insurance, disability benefits insurance, and any other insurance as may be required by law.  - B. The Client will pay the Contractor the sum of seventy five dollars (\$75) for each vehicle towed and unclaimed thirty (30) days after towing. This sum may be negotiated on a case by case basis for any vehicles weighing over 10,000 lbs, vehicles that require the use of a winch to be removed, or if said vehicle is full of trash.
 - C. The Client will not be responsible for any storage fees.

- 5. Business of Independent Contractor. Contractor may engage and retain the right to perform services for other clients and is not required to devote all of his energies exclusively for the benefit of the Client.

Today the Canal serves as part of the Atlantic Intracoastal Waterway, and approximately two thousand pleasure boats use the waterway annually.

NOW, THEREFORE, BE IT RESOLVED by the County of Camden, North Carolina, that it hereby commemorates and recognizes the 200th anniversary of the Dismal Swamp Canal.

"Attached is a model resolution for you to consider as you plan local strategies in support of Medicaid relief for counties. Per our email of last week, we know that Representative Julia Howard of Davie County has a county Medicaid relief bill ready to Representative Howard co-chaired the Blue Ribbon Commission on Medicaid. In addition, we expect county Medicaid relief bills to also be introduced on behalf of the Blue Ribbon Commission by the other co-chairs, Senator William Purcell of Scotland County and Representative Edd Nye of Bladen County."

"At this early stage of legislative development, it is more important for you to communicate the severity of your needs back home rather than favoring particular approaches. We anticipate a variety of approaches to county Medicaid relief. Creating momentum for relief is our primary objective at this point in time; favoring any particular approach over another one this early in the session could inhibit the conversation, rather that further it. Please help us strengthen our position by being consistent in stating the need in your county, by supporting a variety of bills, and by having personal conversations with your legislators about any resolutions you adopt."
